Up to 1'000: for each fraction of 30 minutes and a period of 12 month: flat fee of CHF 40.00
Up to 25'000: for each fraction of 30 minutes and a period of 12 month: flat fee of CHF 80.00
Subsequent archiving of a live stream recording: flat fee of CHF 75.00 for all web performances (per fraction of 30 minutes)

For **Physical CD and Bundle** the statutory rates are applied:
less than 5 minutes: CHF 0.009 cts per copy/download
over 5 minutes: CHF 0.017 cts per minute or fraction rounded up, per CD/downloads
Minimum fee: CHF 40.00

6. What the licence covers

The Licence covers the communication to the public through digital services or physical CD/LP of musical repertoire under copyright at Editions Bim. It covers only the author's musical copyrights. Please contact the relevant rightholders for any other rights involved (e.g. neighbouring rights as movie, text, picture, photo etc.). The licence grants the amount of streams, downloads during 12 month term.

7. Territory

The Licence is attributed for the distribution worldwide.

8. Credits

The name of the composer and the exact title of the work have to be mentioned in the booklet and/or on the permanent container of the recording, as well as on the digital download/streaming description.

The Publisher has to be mentioned in following way: Editions Bim Sàrl, Switzerland - editions-bim.com

9. Payments

By credit card (Visa, Amex, Mastercard) - an invoice will be provided by the Licensor for the initially due amount according to the indications of the Licensee.

An accounting statement shall be issued every 12 month for additional downloads or further physical releases.
